3. At the satisfactory conclusion of the work, and following inspection, \$1,000 of the \$3,500 surety guarantee will be returned. \$2,500 of the cash surety will be held for one-year as maintenance bond towards repairs if the work done does not remain in good condition.						
4. Traffic control is the responsibility of the applicant. However, additional measures may be required if it is found that an unsafe condition exists or it may determined that it is in the best interest of safety to have a police officer present.						
5. I understand that the fee may be adjusted if upon inspection is it detemined that the area of disturbance is greater than what was stated, or that the scope of work involves more than what was indicated on the application.
