Minimal flood proofed electrical equipment is allowed and no mechanical or plumbing devices shall be installed below the Design Flood Elevation.										
4.	The walls of the enclosed areas below the Design Flood Elevation shall be equipped and remain equipped with Flood vents as shown on the Permit and released plans and specifications.										
5.	Any alterations or changes from these conditions constitute a violation of the Permit and may render the structure uninsurable or increase the cost of flood insurance.										
6.	That the owner and subsequent owners agree to allow a representative of the Borough of Manasquan in the premises to verify compliance with this agreement at least once each year. The Borough representative will provide at least 48 hours notice of such visit.
