Regular Meeting of Mayor and Council was convened at 7:03 p.m. on June 18, 2018 in Council Chambers of Borough Hall with Mayor Donovan presiding.

Mayor Edward Donovan read the statement re: Open Public Meetings Act of 1975 and that adequate notice has been provided by transmitting the Resolution of Annual Meetings to the Asbury Park Press and the Coast Star, by posting it in the Borough Hall on a bulletin board reserved for such announcements, and by posting it on the official website of the borough.

Mayor Donovan welcomed the audience and invited them to join in a moment of silent prayer and a salute to the Flag.

ROLL CALL: Present: Council Members Jeffrey Lee, James Walsh, Michael Mangan, Gregg Olivera, and Joseph Bossone

Absent: Council Member Richard Read

Also present were Borough Administrator Tom Flarity and Borough Attorney Mark Kitrick.

Audience Participation

Council Member Mangan went over what has been discussed regarding the Sea Watch property and the possibility of what can be done with the property as it relates to a rebuild. He also went over how the Borough acquired the property and advised that this is a summer of 2020 project. He stated that there will be more public meetings regarding the project to keep the residents informed.

Council Member Walsh made a motion to open the meeting up to the public, seconded by Council Member Mangan. Motion carried unanimously.

Carol Budisak, 77 Beachfront submitted a petition to stop development at Sea Watch and voiced her concerns and opinion on the Sea Watch property as it relates to development of the property.

John Kelly, 59 Beachfront voiced his concerns and opinion on the Sea Watch property as it relates to a rebuild.

Pat Connolly, 65 Ocean Avenue stated that she is very concerned with the lack of inclusion of Green Acres Program in the current conversations about the redevelopment of Sea Watch property. She went over the history of the property and Green Acres and voiced her concerns and opinion on the Sea Watch property and Green Acres Regulations.

Mayor Donovan responded to Ms. Connolly and stated that she mischaracterized what the Borough has been doing and advised that at every step of the way have informed the county and Green Acres of what the Borough was doing. He stated that they will continue to inform and will continue to seek their guidance as to what can be done at the property.

There was discussion between Ms. Connolly and Mayor Donovan about reaching out to Green Acres.

Council Member Mangan advised that council is responding so harshly because there are processes in place and to suggest that council could ignore them is a bit off. He stated that the committee is being appointed tonight so as far as terms of ideas, plans, or specifics none exist yet and that is the purpose for the committee being appointed. He reminded everyone that this is just the beginning of the process.

Mr. Kitrick stated that the Borough has no choice but to have interaction with Green Acres as it was part of the funding mechanism years ago. He stated that it is a legal impossibility for a building to go up without any interaction with Green Acres.

Barbara Cooper, 10 Second Avenue inquired about the block and lot of Sea Watch and why the tax map shows the bungalows under separate lots.

Mr. Kitrick stated that legally it is one lot but for tax purposes there were tax designations for the bungalows.

There was discussion on the leased bungalows and what falls under Green Acres.

Carolyn Burke, 451 E. Main Street voiced her opinion on the rebuild of Sea Watch and requested that the whole community be included in the committee being formed.

Clair Morrison, 71 Second Avenue inquired about a liquor license being put at Sea Watch.

Mayor Donovan stated that nothing has been eliminated but there are no plans for anything until the Borough can find out what they can do with the property and what is best for the property.

Council Member Mangan stated that a food service was mentioned at the MBIA meeting and that is the main idea right now. He stated that this will require Green Acres approval and more specifics to get an approval.

Mayor Donovan stated that there has not been any discussion on putting a night club at the property but a restaurant has been mentioned with a liquor license and without a liquor license but there are no plans and nothing has been fully vetted yet as this is just in the beginning stages of discussion.

Chris Morrison 71 Second Avenue voiced his concerns on the possibility of a restaurant being at the property. He wanted to make sure that a Leggett's or Osprey type scenario would not be put in at Sea Watch property.

Mayor Donovan stated that a night club is a nonstarter and will not even be thought about for the Sea Watch property.

Council Member Walsh made a motion to close the public portion, seconded by Council Member Mangan. Motion carried unanimously.

- a. The licensee shall provide six (6) qualified, uniformed, security persons who shall be assigned to duty, about or adjacent to the licensed premises from the hours of 7:00 p.m. to 3:00 a.m. on those Fridays, Saturdays, and legal holidays upon which the licensee is open for business. Three (3) qualified, uniformed security persons shall be assigned to duty about or adjacent to the licensed premises from the hours of 7:00 p.m. to 3:00 a.m. on Sundays, Mondays, Tuesdays, Wednesdays and Thursdays upon which the licensee is open for business unless such day is a legal holiday. One exterior security person shall be stationed in the Second Avenue parking area.
- b. The maximum occupancy for the licensed premises shall be equal to one (1) person for each five and one-half (5 ½) square feet of floor area which is not covered by bars or working spaces.
- c. There shall be no "go-go dancing," "mud wrestling," "nudity," "topless dancing" or any lewd activity conducted on the licensed premises.
- d. The exterior security guards shall wear a shirt clearly marked, on front and back, "Osprey Security."
- e. All windows to the licensed premises shall be closed at all times during hours of operation. All doors shall remain closed during hours of operation except for access to and from the licensed premises. Exterior doors shall not be left continuously open to provide access.

WHEREAS, the said Driftwood Hospitality Group LLC, t/a The Salty Whale & Guest House judged to be entitled to a Plenary Retail Consumption Liquor License (Hotel/Motel Exception).

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Manasquan, County of Monmouth, State of New Jersey, that the Borough Clerk is hereby designated, authorized and instructed to issue and deliver a Plenary Retail Consumption Liquor License (Hotel/Motel Exception) to the said, Driftwood Hospitality Group LLC, t/a The Salty Whale & Guest House to sell alcoholic beverages at 390 East Main Street in the Borough of Manasquan, New Jersey, until midnight, June 30, 2019, subject, however, to the following conditions:

- a. There shall be no live music or entertainment of patrons by any group exceeding four people; however, the applicant shall have the privilege of applying to the governing body, or its designated committee, to have a larger group on special occasions. In such event, the applicant shall advise the governing body of the proposed date for the entertainment by live music of a group exceeding four people, the proposed time of the event and the number of entertainers proposed at the event.
- b. There shall be no consumption of alcoholic beverages outside of the structure on the property, except for the "proposed outdoor area" shown on a diagram submitted as part of the renewal application for this liquor license. The outdoor area consists of 510 square feet to the east of a portion of the structure labeled on the diagram as "ENCLOSED PORCH roof over." Alcoholic beverages may only be served and consumed in this area between the hours of 11:00 a.m. and 10:00 p.m. Alcoholic beverages shall be available to patrons only through service by waiters or waitresses. Only a service bar may be maintained in this area. No patrons may be seated or standing at the service bar. No live music or amplified music shall be conducted in this area except for an acoustic guitar. Landscaping shall be provided in accordance with the diagram outlining this area. It is the intention of this provision to prohibit the consumption of alcoholic beverages in the yard or parking lot areas of the premises known as The Salty Whale & Guest House, except in the outdoor area described above.
- c. The total lineal feet of public bar shall not exceed seventy (70) linear feet.
- d. No alcoholic beverages sign on the exterior or adjacent grounds shall exceed $4\frac{1}{2}$ square feet in area.
- e. No renewal or transfer of this license will be allowed, except for or to a hotel containing at least 50 rooms.
- f. The licensee shall provide two (2) qualified, uniformed security persons who shall be assigned to duty, about or adjacent to the parking lot serving the licensed premises from the hours of 7:00 p.m. to 3:00 a.m. on those Fridays, Saturdays and Holidays from May 15th through September 15th, when the licensee shall be open for business. At least one of the security persons shall be stationed directly in the parking lot during the hours of 7:00 p.m. to 3:00 a.m.
- g. The licensee shall provide a litter patrol which will remove litter within 200 feet of the licensed premises before 9:00 a.m. each morning following an operational day from May 15th to September 15th.
- h. No bottles or cans shall be dumped in the solid waste dumpster maintained by the license holder between the hours of midnight and 7:00 a.m.

- i. At any time the licensed premises offers live entertainment or amplified music, all doors shall remain closed except for access to and from the licensed premises and all windows shall be closed. Exterior doors shall not be left open continuously. This condition does not apply to any rooms available for rent.
- j. No live music is permitted at the licensed premises after 1:30 a.m.
- k. Alcoholic beverages shall be available for patrons in conjunction with food service in Dining Area "D."
- l. Alcoholic beverages shall be available to patrons only through service by waiters or waitresses in Dining Area "D."
- m. Alcoholic beverages may be served and consumed between the hours of 10:00 a.m. and 10:00 p.m. on Sunday, and 11:00 a.m. to 10:00 p.m. on Monday, Tuesday, Wednesday and Thursday, and between the hours of 11:00 a.m. and 11:00 p.m. on Friday and Saturday in Dining Area "D".
- n. Dining Area "D" shall be vacated by 10:00 p.m. between Memorial Day and Labor Day and by 11:00 p.m. between Labor Day and Memorial Day. After that hour, there shall be no service of alcoholic beverages or food in this area.
- o. No amplification devices shall be located on the exterior of the building.
- p. No outside bar area, portable bars or similar structures or equipment shall be located in Dining Area "D."

Recreation/Beach Committee – Council Member Bossone reported that the beach is fully open for the summer, new beach signs have been installed with rules and regulations, summer recreation offerings are listed on the website, there is an upcoming paving project and knee wall project at the beach garage, and he reported on the events coming up at the beach. Council Member Olivera advised that there is a Citizen Advisory Committee in place which is made up of citizens who wanted to get involved and they will be reached out to also.

Council Member Mangan went over the Citizen Advisory Committee and how it was established and what it consists of.

Mark Fendl, 13 Taylor Avenue inquired about the stop sign on Parker Avenue when traveling west towards Surf Taco and advised that the traffic is backed up across route 71 and blocking it.

Mayor Donovan stated that it will be looked into.
