APPROVAL OF MINUTES

Council Member Mangan requested that the April 7, 2014 meeting be changed to reflect a mis-statement that the council member stated at the meeting where the Borough will be moving forward with phases 2 and 3 it should only be redoing the North End of Sea Watch phase 1.

April 7, 2014 Work Session and Regular Meeting

Council Member Mangan made a motion to approve the minutes as amended, seconded by Council Member Sinneck. Motion carried unanimously.

COMMITTEE REPORTS

Beach Committee – Council Member Donovan reported on behalf of Council Member Bossone. He read a prepared statement about the message board controversy at the beach headquarters. In this statement Mr. Bossone stated that he has been talking about this in his committee reports for months and it should not have been a surprise to anyone. He advised that the sign was purchased by the Beach Restoration Fund for two reasons; to let people know about upcoming events or changes or cancellation to the events and to notify residents of any weather related storm warnings. He also mentions other messages that can be put on the sign to get out as fast as possible to the public. Council Member Donovan also read a portion of the prepared statement regarding the lettering on the building. He also read that Council Member Bossone has not met with the Beach Committee yet to discuss the additional surf beach. Council Member Donovan reported on the beach revenues to date compared to last year and the dates and hours the beach office will be open. He advised that there is a band concert and fireworks this Saturday starting at 7:30 with a rain date of Sunday and Sea Watch Parking is by permit only through September 30.

Mayor Dempsey stated that with the new sign at the beach headquarters the Borough should be receiving points which will help lower homeowners flood insurance through the CRS program.

Law and Code Committee – Council Member Sinneck reported on the Code/Construction Department revenues and permits issued to date. He advised that the inspections have gone to am or pm scheduling and that the owner does not need to be present just someone that is 18 years of age or older.

Public Works Committee – Council Member Donovan reported that public works will be painting lines on the roads this month and please be alert when approaching work areas, the on-line auction went well and took in approximately \$29,000, the water at the docks has been turned on, the bike auction went off last Saturday and \$501 was collected for the bikes, DPW will be assisting the beach department with the installation of showers and fountains on the boardwalk, and the DPW and the Environmental Commission are sponsoring a paper shredding event on May 24, 2014 from 9 a.m. to noon in the Fourth Avenue parking lot for Manasquan and Brielle residents only as it is not a County sponsored event.

Administration and Finance Committee – Council Member Mangan reported for Tourism that May 22, 2014 from 6 to 8 p.m. will be the Cocktail Party celebrating the re-opening of the beach with a ribbon cutting at Main Beach at 5:30 p.m. He also advised that May 24, 2014 will be the fireworks with the rain date of May 25, 2014 sponsored by The Mill with the band Retro Kings starting at 7:30 p.m.

Public Property and Parks Committee – Council Member Olivera thanked the residents of the Borough for all the positive responses to the Parks Day. He advised that he has followed up on some concerns that were voiced while visiting the parks in town regarding trees. He reported that the Life Saving Station has a few minor items that need to be addressed and it will then be completed and ready for use. He reported that there was a very positive cross functional meeting with Council Member Donovan and Council Member Mangan with the Borough Engineer, Maser Consulting to look at potential grants from the County, State, and Federal Departments to work on some of the projects that need to be done. He advised that some of the projects being looked at are the bulkhead, Mallard Park, and Hancock Park.

Public Safety & Recycling – Council Member McCarthy reported that the Police Department has been notified that there has been 2 events where two seniors have been alerted that a family was in jail in a different state and people requested large amounts of money via gift cards. He advised that the scam is out

there and wanted to make sure that everyone is aware to be suspicious and if it sounds unusual please notify the police department. He reported that officer Robert Wagner has received an award from MADD (Mothers Against Drunk Driving) for his involvement last year for 10 DWI arrests and there will be a luncheon in June where Officer Wagner will be one of the officers honored statewide for his efforts in cracking down drunk driving and he deserves credit and mention tonight. He reported that Reverend Gratzel and the members of the Manasquan Police Department and other law enforcement agencies from neighboring municipalities, and families that lost a child to heroin did a program "Say Something About Heroin" and it was very well attended. He advised that there will be other events coming up that will be sponsored by Reverend Gratzel and local municipalities. He informed the council and the audience that former Police Chief Dan Scimeca has been diagnosed with ALS and he attended an event yesterday at Leggetts and the PBA has agreed to give a donation to the annual ALS plunge on behalf of Dan Scimeca.

Mayor Dempsey made a statement to try and let the audience know how the council works. He stated that each council member is in charge of a specific committee and there are 2 other council members on the committee and if all 3 council members go to the meeting the Mayor is not allowed to attend or participate as it will violate the Open Public Meeting Act. He advised that a lot of the time he does not know exactly what the committees are doing if they do not report back to him. He stated that Council Member Bossone can not be here but there are 2 other council members that are on the beach committee that may be able to answer questions.

AUDIENCE PARTICIPATION

Council Member Sinneck made a motion to open the meeting to the public, seconded by Council Member McCarthy. Motion carried unanimously.

Mary Ryan, 113 Beachfront handed a copy of the online petition to the Clerk for distribution to the Council which showed the last 10 signatures out of 63 in opposition of the new beach headquarters digital sign. She read a prepared statement from the general membership of the Manasquan Beach Improvement Association (MBIA) requesting that the electronic message board and the vinyl signage on the beach headquarters be removed. She also inquired about the distribution of funds from the Restoration Fund.

Mona Girard, 30 Willow Way showed the council a water filter from her house and that it has been in for 2 weeks in the system that the town installed. She wanted to know if this is normal because she does not drink the water because she is afraid to drink it. She would like someone to look into this and let her know if she should still be having this problem since the pipes have been replaced. She also inquired about Old Squan Village being paved and she went over the conditions of the road after all of the repair work that has been done to the road and she is asking that these roads be re-surfaced as soon as possible.

Council Member Donovan stated that the Borough applied for a grant from NJ Department of Transportation and the Borough learned a week ago that the grant application was denied and the NJDOT has approved other projects not the Borough's projects. He stated that this was discussed at budget time and money was authorized for general paving that will be used to take care of streets that are in desperate need of repair.

Council Member Mangan went over what was discussed at budget time and that only a few streets will be able to be done. He stated that now that the budget has been passed the discussions can begin on which streets will be included in the 2014 budget cycle.

There was discussion on the streets that the council has received estimates for and that Old Squan Village has been included in the list.

Ms. Girard inquired as to where Old Squan Village was on the list.

Council Member Mangan stated that there is no placement on the list it is all the bad streets in town and estimates.

Robert Reininger, 209 Beachfront voiced his opinion on the Beach Headquarters sign and that he is not in favor of it. He went over a meeting that he attended where he was assured that there would be a partition in front of the women's bathroom which never went up. He asked the Mayor to consider putting up what was designed and it would be a shame to do anything besides what was designed to go there. He stated that at the same meeting he was assured that there would be no signage on the building except for the office and ladies room. He asked that council take a look at this again.

Curran Fallon, 306 Brielle Avenue stated that he came to the meeting on May 5, 2014 and appreciated Council Member Bossone's response to his request and he sent an e-mail to Council Member Donovan and Council Member Olivera and he did not receive a response from that e-mail. He wanted to make his request clear that he was asking for an additional surfing beach not for an expansion on what currently exists.

Mayor Dempsey stated that last year periodically the beach was extended at Whiting. He stated that the committee has not met to discuss Potters Beach.

Mr. Fallon stated that this is a Borough responsibility and it is up to the town to make it safe for everybody in the surrounding community who chooses Manasquan to surf at.

Mayor Dempsey stated that the committee would have to meet and Council Member Donovan advised that he has contact information. Mayor Dempsey stated that the committee can meet but they can not authorize the new beach until it comes before council.

Council Member Olivera stated that he also reached out to members of the surfing community that he knows to get their input and they are in agreement that there needs to be an additional surfing beach.

Robert Richardi, 215 Beachfront voiced his concerns of the vinyl signage on the Beach Headquarters and that he is not in favor of it.

Carl Danish, 96 South Street, agreed with the need to provide additional beach for surfers and stated that he would like to see a meeting of the committee and the surfers to discuss the surfing beaches.

Council Member Sinneck made a motion to close the public portion, seconded by Council Member Mangan. Motion carried unanimously.

Council Member Donovan made a motion to close the regular meeting at 8:51 p.m. seconded by Council Member Mangan. Motion carried unanimously.
