Work Session and Regular Meeting Minutes - January 20, 2015 (absent Mangan)

Council Member Sinneck made a motion to approve the minutes, seconded by Council Member McCarthy. Motion carried unanimously withy Council Member Mangan abstaining.

Work Session and Regular Meeting Minutes – February 2, 2015 (absent None)

The Municipal Clerk requested that the February 2, 2015 minutes be held until the next meeting to give council time to review.

COMMITTEE REPORTS

Public Safety Committee – Council Member McCarthy thanked the residents for staying off the roads during the inclement weather on Saturday into Sunday as well as last night and into this morning. He reported that there were no significant accidents and that if the prediction is for snow please try and stay off the roads. He reported that there has been discussion on no parking in the business district over night from Route 71 to South Street which would make it easier on snow plowing and street cleaning. He stated that he received a report from Lt. Kleinknecht advising that dispatchers Paul McMahon and Eileen Pressey have entered all the data regarding the new flood notification program and he wanted to thank them for their efforts. He reported that the ALS plunge over the weekend was a success as they have raised over \$300,000 and he thanked everyone for participating in the plunge.

Mayor Dempsey stated that there is an ordinance in affect now that allows the Borough to remove the cars from the street during a snow emergency if so desired. He stated that he does not really want to tow the cars but he would like a copy of the ordinance put on the website so residents are aware of the penalty for leaving a car in the street during a snow emergency.

Recreation & Environment Committee—Council Member Olivera reported that Jim Priolo already covered the Open Space in his monthly report. He stated that he notified the Shade Tree that he will be the new liaison. He stated that the Borough received a substantial amount of e-mails regarding balloon release portion of the ALS Plunge over the weekend. He stated that he researched this issue 2 years ago and came to the point that most of the issues involving a lot of the balloon releases were milar balloons and strings attached to the balloon and he advised that this balloon release was not milar balloons and there were no strings attached. He advised that most of the ordinances that were on the books regarding balloon releases were being repealed because of the fact that they were unenforceable. He stated that based on the large volume of e-mails and some of the comments by council the committee will look at this issue again for the future.

Council Member Sinneck stated his opinion and his knowledge of the balloons and how they affect sealife.

There was discussion on the balloon release and the possibility of putting the statement "no balloon releases" on the application for use of borough property.

Administration & Finance Committee – Council Member Mangan reported that the Borough is in budget season on the finance end and the 21st is a very important budget meeting where capital projects will be discussed. He stated that he met with the clerk's office and advised that they are working on new website, fee schedule, clerk's annual report, and the personnel policy. He went over the fee schedule process and the timeline. He also stated that if there are any fees that need to be changed before the process is completed then they would need a separate ordinance before the completion of the fee schedule.

Public Works & Grounds Committee – Council Member Donovan reported that the last day for Christmas tree pick up is February 27, 2015 and all decorations and stands need to be removed. He stated that in order to help Public Works with efficiency and safety during snow removal to advise residents to park off the street which is an ordinance and to remove all sports equipment from the street. He also stated that there is a borough ordinance that states that snow or ice is not permitted to be thrown back into the street. He stated that if the ice at Mac's Pond becomes thick enough for skating the green flag will go up. He advised that the Borough has received notice from Assemblyman Rible's office that the Borough has received a \$225,000 Safe Route to School Grant which will help fix sidewalks within a mile of the schools.

Building, Planning & Zoning Committee – Council Member Sinneck reported that the work load in the code/construction department is steady and the turnaround time for permits is within the guidelines.

Beach Committee – Council Member Lee reported that the committee is working on finalizing their opinion on beach fees for 2015, discussing the Third Avenue Parking Lot overnight parking, dune mitigation project, Sea Watch Property reconstruction, request from Verizon to use beach building, and dogs on the beach enforcement.

AUDIENCE PARTICIPATION

Council Member Olivera made a motion to open the meeting to the public, seconded by Council Member Mangan. Motion carried unanimously.

There being no comments from the audience Council Member Donovan made a motion to close the public portion, seconded by Council Member McCarthy. Motion carried unanimously.

Council Member Olivera made a motion to close the regular meeting at 9:23: p.m. seconded by Council Member Sinneck. Motion carried unanimously.
