He also reported that the Infrastructure Protection and Stormwater Conveyance Project has gone out to bid and the bid opening will be October 8, 2015 at 11 a.m. He advised that the committee met with the Shade Tree Commission at the Second Avenue Parking Lot to discuss the trees in the area as well as the Third Avenue Parking Lot, Borough right of way planting and trimming and planting along the Sea Girt Army Camp. He reported that the Shade Tree will be at the October 5, 2015 meeting to have a brief presentation on the Borough right of way tree program. He reported that as the liaison he received a formal request to attend the library board meeting which he will attend. He advised that there is a home composting workshop on October 8, 2015 at 7 pm at the DCI building. He thanked Council Member Sinneck for all his work on the Environmental Commission.

Building, Planning & Zoning Committee – Council Member Sinneck reported that 1,000 permits year to date have been issued, 21 demolitions, 40 new homes under construction, 2 new home permits issued this

month and he went over the revenues for the year. He stated that the work load continues at the same pace as it has for the past three (3) years.

Beach Committee – Council Member Lee congratulated Council Member Sinneck and stated that it was a pleasure to serve on the Green Team with him. He thanked council for the passing of the Second Avenue Parking Lot Project and Bond. He reported on the process with a pre-construction meeting (internally) on Thursday which will be followed by a public meeting for the area shortly thereafter. He reported that the NJDOT Maritime Resources Division notified the Borough that they are still working on the permit process for dredging. He reported on the NJ DCA ROID Grants application for beach entrance mats.

Council Member McCarthy stated that with the starting of the school year there are parking restrictions around the school with timed parking and there is going to be work on the gas line throughout town.

Council President Donovan stated that there will be paving on Broad Street starting around Columbus Day.

Public Works & Grounds Committee – Council Member Donovan thanked Council Member Sinneck for being the liaison to the Environmental Commission and the chair before that. He reported that the elevation for the East Virginia Avenue and Brielle Road lift stations is substantially completed, 2 new trucks were order for the public works, and leaf season begins September 28 and starts east of the railroad tracks which is posted on the website. He reported that hydrant flushing will begin on October 12 and will be flushed at night.

AUDIENCE PARTICIPATION

Council Member Sinneck made a motion to open the meeting to the public, seconded by Council Member Lee. Motion carried unanimously.

Barbara Cooper, 10 Second Avenue voiced her concerns about the Second Avenue Parking Lot Project and the removal of the existing trees.

Council President Donovan stated that there will be a public meeting with elected officials, Borough engineer, and contractor which the public will have a chance to voice their concerns or ideas. He reported on the concerns that have been voiced regarding the placement of the shed for Little League.

Patricia Merz, 26 Second Avenue voiced her concerns with the Second Avenue Parking Lot Project and wants the trees replanted near the sidewalk if possible.

Norman Merz, 26 Second Avenue voiced his concerns with the Second Avenue Parking Lot Project and the grassy area between the sidewalk and the parking lot. He also inquired as to the amount of cars that are in the parking lot and is it necessary to have a fourth row for parking.

Claire Morrison, 71 Second Avenue voiced her concerns about the new shed and cameras at the skate park.

There was a brief discussion on cameras and different types of cameras.

Barbara Cooper, 10 Second Avenue voiced her concerns about broken lights for the skate park and the misuse of the lights at the rink after hours.

There was a brief discussion on the use of the lights at the rink.
