Ms. Jacobson inquired as to what streets are being re-paved.

Mayor Donovan stated that there are various intersection improvements that are going to be made and various streets but he does not have a list of them right now.

There was a discussion on where some of the improvements are and NJNG work being done in the Borough and them repaying various streets throughout the Borough.

Mr. Kitrick went over the restrictions in the agreement for the Life Saving Station.

Mary Ryan, 113 Beachfront requested guidelines for the use of the Life Saving Station and that some effort be made to write out some clear guidelines on the use of the building.
