COMMITTEE REPORTS

Administration and Finance – Council Member Mangan reported that the new CFO Amy Spera is doing a fantastic job as well as the staff stepping up and making sure things get up to speed. He went over the staffing in the finance office with Amy and Steve and the interim administrator John Trengrove. He advised that the borough will be looking into building security upgrades. He reported that the CFO has prepared a review of the debt and revenues for 2017 which will be important when the discussions start in regards to repaying the community disaster loan.

Special Services Committee — Council Member Read reported that he met with the Cable TV advisory committee and the committee would like the opportunity to come before council at budget time to talk about funding. He advised that he will be following up on the Sustainable Jersey grant opportunity.

Public Safety Committee – Council Member Olivera thanked council for approving the Chapter 159 Drunk Driving Enforcement Fund. He reported that the money comes from the department of law and public safety as a grant and that 80% of the grant money goes to fund police officer's on Friday and Saturday during the summer time and the rest goes towards the maintenance and operation of the breathalyzer equipment. He read a statement from Chief Bauer reminding residents that if they see something suspicious say something in light of the recent incident in Seaside.

Beach Committee – Council Member McCarthy reported that the bathrooms at the beach will remain open during the warm weather and reported about the recent storm and the sand that has accumulated on the walkway. He advised that the area is being worked on in order for people to walk. He reported that the Shade Tree Commission is hopeful that the fall planting season will allow them to plant some trees east of the bridges. He reported on Hurricane Matthew storm that is in the Caribbean and advised that it is too early to determine any impact on the area at this time.

Building, Planning & Zoning – Council Member Walsh advised that he has nothing to report at this time.

Public Works & Grounds – Council Member Lee thanked DPW for their help in the beach area to clean up sand from the walkway. He reported on the leaf pickup schedule, bollards being removed from Third Avenue parking lot, hiring of new superintendent, and the cleanup of Alice Hemphill Park.

AUDIENCE PARTICIPATION

Council Member Walsh made a motion to open the meeting to the public, seconded by Council Member Mangan. Motion carried unanimously.

Bob Grunder, Perrine Blvd. resident voiced his concerns on the bulkhead project and stated that there is nobody on town council that knows what they went through this past summer and the council does not understand the whole scope of the job. He wanted to know the schedule for the completion of the project and the completion date as well as how much the project costs, how much was in overruns and how is this being funded. He also wanted to know what year Manasquan will see any net return from this investment.

Mr. Priolo advised that the dredging, piles and dock work will be done by the end of December. He also advised that the remaining work to be done next would be the final paving on the road which would be early spring. He advised that the council approved a change order to add in all the replacing of the dock work. He stated that he could get the dollar amount of the project but does not know it right now.

Council Member Mangan went over the concept of the project and the process to get to the point where the Borough is now with the project.

Mr. Grunder stated that he disagreed with a lot of the projection of the project. He voiced his concerns on the project and the amount of people on the job. He wants to know when significant events for this project will be completed. He asked a bunch of questions regarding the project.

Mr. Priolo stated that there is a schedule from the contractor that itemizes everything.

Council Member Mangan advised when the project has been mentioned at meetings.

Council Member Lee advised that the committee meets every 2 weeks at the site with the contractor, Mayor Donovan and Interim Administrator John Trengrove.

Mary Ryan, 113 Beachfront inquired about the new water meters and requested how many homes are not in compliance.

Council Member Lee advised that as of two (2) weeks ago there was roughly 800 homes that have not had the new meter installed yet.

There was discussion on where the majority of the homes are in town and how they will be contacted.

Ms. Ryan inquired about First Avenue and Stockton Lake Blvd. being paved.

Mayor Donovan stated that First Avenue is definitely on the list but there is still a lot of work being done in the area and he advised of the moratorium that is placed on newly paved streets.

Council Member Mangan went over the roads project and how much certain streets would cost. He stated that we would be looking to the county for help with the cost of repaving First Avenue.

There was discussion on the Stockton Lake Blvd. project which was stopped due to the DOT freezing funding for road projects.

Ms. Ryan inquired about the animal control contract and if this would include an officer that rides around.

The Municipal Clerk advised that the officer is not part of the contract with the Humane Society but a part of the county program.

Ms. Ryan inquired about the beach bathrooms being opened.

Council Member McCarthy advised that this would depend on the weather.

Marilyn Jacobson, 59 McClean Avenue inquired about the dredge spoils and if the change in location will trigger a change order.

Mr. Priolo advised that this would not trigger a change order and the intention is to recapture dredge spoils and use them as fill underneath Perrine and behind the bulkhead and if there is any excess it would be removed.

Ms. Jacobson inquired about the 20% overage from the original contract price and why was it put out to bid if all of the research wasn't done prior.

There was discussion on the project and the process that was taken to get to the contract execution and change order.

Thomas Abruzzo, 339 First Avenue advised he was before the council previously inquiring about raising the minimum flood elevations on new construction. He voiced his concerns and opinion on the reasoning for raising the minimum flood elevations. He went over his situation with FEMA and ICC money.

There was discussion on the current flood elevations.

Bob Grunder, Perrine Blvd. resident inquired if his street will be opened in December.

Mayor Donovan advised that the last conversation with the contractor was that the street will not be paved but it will be open.

Mr. Grunder inquired about return on investment for this project.

Council Member Mangan stated why he went with the current project.

Council Member Olivera stated why he went forward with the project approval.

Council Member Lee stated that this project will last much longer than the 17 years it will be funded and he believes this is a financially responsible project.

Marilyn Jacobson, 59 McClean Avenue inquired about the runs in town and is there any accounting for revenue for the runs.

Council Member Mangan advised that the borough is looking into the percentage that an organization should contribute for the use of borough property.

Ms. Jacobson voiced her opinion on the new position that will oversee recreation and the beach.

Council Member Walsh made a motion to close the public portion, seconded by Council Member Olivera. Motion carried unanimously.

Council Member Mangan made a motion to close the regular meeting at 8:41 p.m., seconded by Council Member McCarthy. Motion carried unanimously.
