#### Energy Aggregation - Update

Council Member Mangan advised that an ordinance was passed last year allowing for the borough engineer to collect information regarding the energy usage as a Borough to provide a study as to whether or not energy aggregation would be beneficial to the residents of Manasquan. He went over the state's involvement for the process for protection of energy.

Dan Nowak, Maser Consultants advised that he has all the data for the supply information from the residents and they are prepared to go to auction and find those suppliers that are interested in bidding for the load. He stated that it should go out to bid in about 4 to 6 weeks and he is very optimistic that savings will be going from 15%.

There was discussion on the process after the bid and moving forward with the aggregation.

WHEREAS, the New Jersey's municipalities support the provision of affordable housing in a reasonable, rational and achievable way, consistent with economic realities and sound planning; and

WHEREAS, the Council of Affordable Housing (COAH) has not adopted regulations to establish the methodology for determining municipal affordable housing obligations since 1999; and

WHEREAS, COAH's inability to adopt regulations resulted in hundreds of municipalities being forced to seek declaratory judgements in the courts in order to comply with the State imposed municipal affordable housing obligations; and

WHEREAS, since 1999 both COAH and the State Legislature have restricted or abolished municipal compliance tools while failing to create new tools and means of compliance to facilitate the construction of affordable housing; and

WHEREAS, the Legislature and Administration need to partner with municipalities to facilitate municipal compliance by enabling new tools which generate funding, provide flexibility, promote transparency, provide incentives for municipalities and further the provision of affordable housing; and

WHEREAS, many municipalities have collected affordable housing trust funds while at the same time tax credits and other financial incentives for construction or rehabilitation have been significantly reduced, impeding the ability of local governments and their partners to advance affordable housing projects; and

WHEREAS, hundreds of municipalities statewide must address significant state and court imposed housing obligations as a result of the State's inability to enact a reasonable statewide policy; and

WHEREAS, it is the responsibility of the state and the legislature to assist municipalities and enact a rational housing policy with achievable obligations, sufficient compliance tools and appropriate financial resources.

NOW THEREFORE BE IT RESOLVED, by the Borough of Manasquan that the State Legislature is urged to pass A4666/S3080, enacting a short-term moratorium on all affordable housing litigation; and A4667/S3081 establishing the "Affordable Housing Obligation Study Commission" to assist in finding solutions to the affordable housing crisis foisted upon municipalities; and

BE IT FURTHER RESOLVED, that we must reach a solution to affordable housing in New Jersey; and

#### COMMITTEE REPORTS

Beach & Recreation Committee – Council Member Lee thanked council for approving the beach staffing and the staff is busy getting the beach ready for the season. He reported that revenues are approximately \$73,000 above last year for a comparative time. He reported on upcoming Tourism events including Thursday, May 25 is the Annual Kick Off Cocktail Party at Leggett's, fireworks are scheduled for Saturday, May 27, and the Memorial Day Ceremony sponsored by the VFW.

Building, Planning & Zoning Committee – Council Member Walsh reported on year to date rental applications, zoning applications, construction permits, and garage sales compared to last year. He advised that there is a scheduled meeting regarding Community Rating Service (CRS) which has a direct impact on the flood insurance that residents will pay.

There was a brief discussion on Air B&B rentals and the ability to license these types of rentals.

Administration & Finance Committee - Council Member Mangan reported that the council has received a request for a waiver for the fee that was imposed for those individuals who did not get their new water meter in on time and that since this has been established by ordinance the fee cannot be waived.

The Borough attorney went over the ordinance and advised that it cannot be selectively enforced.

Council Member Mangan stated if an extraordinary circumstance arise-the council will be informed for their review. He thanked the CFO for reaching out to the Borough's bond counsel and setting up a preliminary meeting.

Public Safety Committee – Council Member Olivera advised that he has nothing to report at this time.

Streets & Buildings Committee – Council Member Read reported that the meeting with the bond counsel was very productive and he is looking forward to a second meeting. He went over the events that were recently held at the High School and reported that the high school lacrosse team is playing in the shore conference championship game tonight. He also reported that the high school library is holding a public book sale on the 20<sup>th</sup> and 21<sup>st</sup> to cut back on the books and make room for new items.

Mayor Donovan thanked the first responders that were called out to a residential fire on Thursday at the corner of Route 71 and Marcellus Avenue.

#### **Audience Participation**

Council Member Walsh made a motion to open the meeting to the public, seconded by Council Member Read. Motion carried unanimously.

Mary Ryan, 113 Beachfront inquired about the energy aggregation and if it diminishes the quality of the energy.

Council Member Mangan stated that it does not diminish the quality and explained how the grid operations work.

Ms. Ryan stated that the Citizen Advisory Committee is a great idea and voiced her support for the committee. She voiced her opinion on the amount of notice that was given regarding the water meter installation process.

Joann Corbe, 465 Euclid Avenue voiced her concerns and frustration with the area in front of her home as it relates to the street and standing water.

Mayor Donovan went over the meeting with bond counsel which will allow the Borough to know what funding is available for the repair to streets throughout the Borough. He stated that if Euclid is not at the top of the list it is really close for repair/replacement.

Council Member Mangan advised that there are different types of issues with the roadways which would include infrastructure on some of the roadways. He also went over the reasoning behind the process of choosing certain streets and the funding process.

Ms. Corbe stated that she was advised that her street would be paved during the bulkhead project paving and she will seek mitigation on this issue if it is not corrected by the winter.

Council Member Lee stated that this is not being taken in stride and Euclid is on the list.

Council Member Olivera made a motion to close the public portion, seconded by Council Member Lee. Motion carried unanimously.
