Regular Meeting of Mayor and Council was convened at 7:03 p.m. on September 18, 2017 in Council Chambers of Borough Hall with Mayor Donovan presiding.

Mayor Donovan read the statement re: Open Public Meetings Act of 1975 and that adequate notice has been provided by transmitting the Resolution of Annual Meetings to the Asbury Park Press and the Coast Star, by posting it in the Borough Hall on a bulletin board reserved for such announcements, and by posting it on the official website of the borough.

Mayor Donovan welcomed the audience and invited them to join in a moment of silent prayer and a salute to the Flag.

ROLL CALL: Present: Council Members Lee, Walsh, Mangan, Olivera, and Read

Absent: Council Member Bossone

Also present were Borough Administrator Tom Flarity and Borough Attorney Mark Kitrick.

Audience Participation

Council Member Read made a motion to open the meeting up to the public, seconded by Council Member Walsh. Motion carried unanimously.

John Ketner, 111 Beachfront inquired as to the number of written warnings and the number violations from May 1 until today for dogs on the beach.

Chief Bauer stated that in 2017 there were 23 calls for dogs either on the beach improperly or running without a leash. He stated that out of the 23 calls 3 were without a leash. He stated that in 2016 there were 28 calls for dogs on the beach or beach walk when they were not supposed to be, 4 were without a leash, one was a service dog and one for not cleaning up after their dog which the owner was issued a summons. He went over the calls for service in 2016 which were 16,540 and 28 were for dog issues on the beach and so far in 2017 there have been approximately 12,500 calls and 23 were for dog issues on the beach.

John Ketner, asked if the borough was taking a proactive approach to dogs.

Chief Bauer stated that in May of 2016 leading up to the summer season there was a press release, an article in the Coast Star, and sent out through the town's website to get the message out about the prohibition of dogs on the beach and beach walk. He stated that on May 1 he had officers check the beach walk twice during their shift and in an eighteen day period from May 1 through May 18 they recorded 201 beach checks. During that time there were 3 violations and during that same period there was one call for a dog on the beach. He advised that the 3 violators were issued verbal warnings and placed in the computer system for future violations.

John Paulovich, 113 First Avenue thanked the members of the board who responded to his letter. He stated that in that letter he asked for the information that the Chief provided. He stated that he walks the beachfront every day and there are violators out there. He provided the Clerk with a picture for council of a dog feces on the beach. He voiced his concerns and opinion on the request to allow dogs a longer period of time on the beach. He asked that the council not vote to change the ordinance this fall and requested it should be moved to the spring so it can be monitored over the winter. He inquired as to how many council members own a dog and asked if they will recuse themselves from voting.

Mayor Donovan stated that all council members pay taxes and they vote on taxes every year along with water and sewer.

Mr. Paulovich went over other items that he had in his letter to council and he is not in favor of the change.

Chief Bauer stated that he is looking for the publisc help by calling the police department when there is a violation.

Mr. Paulovich voiced his concern on the amount of dog feces bags that are left near a garbage can if it is full.

Jack Langella, 404 Pine Avenue inquired about pickleball at Mallard Park and provided the Clerk with pictures of a court. He voiced his concern about the size and noise of a pickleball court and the height of the fence.

Kevin Reynolds, 25 S. Potter Avenue voiced his concern about the pickleball court that is in the plan for Mallard Park.

Mary Ryan, 113 Beachfront stated that all of the comments that she has been making are her own opinion and concerns and not from the MBIA. She commented on the police and the dog issues and stated that the dispatchers have been very responsive in sending an officer to the beach if they are available. He suggested that the borough find a way to have an officer have more of a presence at the beach to give summonses. She advised that she is not in favor of extending the timeframe that dogs are allowed on the beach but would like to see more responsibility on the dog owner community to make sure that the rules are followed and understood.

Council Member Walsh made a motion to close the public portion, seconded by Council Member Olivera. Motion carried unanimously.

Request from Spirit of '76 to Open Early on December 24, 2017

There was discussion on this request.

Council Member Walsh made a motion approving this request with an opening time of 10 am, seconded by Council Member Read. Motion carried unanimously.

The Municipal Clerk stated that this approval will be memorialized by resolution at the next scheduled council meeting.

Dogs on Beach Extension - Follow Up

Council Member Lee thanked everyone for their input, comments, concerns, and opinion. He read a letter from Council Member Bossone who was unable to attend the meeting tonight. He stated that the committee has discussed this at length and has taken into consideration all of the concerns and opinions of everyone and believes that the extension would work from October 1 to April 15. He advised that the April 15 date would be the end of the time because the beach crew starts to get the beach ready for the season at the end of April. He stated that this would be a trial time which will need to be re-visited early in 2018. He went over mutt mitts, signage, and enforcement of dogs on the beach.

Council Member Olivera inquired about the funding for the extension of dogs on the beach.

Council Member Lee stated that the CFO is looking into budgets to see where the money can come from for any extra expenditures for this pilot program. He also stated that a police officer will not be at the beach 8 hours every day, but the intent is to do this for 2 or more weeks to get the word out and educate the dog owners on the rules and regulations.

Council Member Olivera voiced his opinion and concerns about dogs on the beach and enforcement in general.

Council Member Read voiced his opinion and concerns regarding dogs on the beach and enforcement.

Council Member Walsh voiced his opinion and concerns regarding dogs on the beach and enforcement. He stated that there needs to be an understanding that not everyone has a dog or likes dogs.

Council Member Mangan voiced his concerns and opinion regarding dogs on the beach and the extension.

Mayor Donovan voiced his opinion on the subject and thanked everyone for their input. He stated action will be taken tonight and it will be memorialized by resolution at the next scheduled meeting.

Mr. Kitrick stated that since this is being done by resolution his recommendation is to re-visit the adoption of this resolution at the first meeting in January.

Council Member Lee made a motion to approve extending leashed dogs on the beach from October 1 to April 15 as a pilot program, seconded by Council Member Read. Motion carried by the following vote: "yes" Council Member Lee, Walsh, Mangan, Olivera, and Read. "No" none.

Council Member Olivera made a motion to remove resolution 235-2017 from the Consent Agenda to be voted on separately, seconded by Council Member Mangan. Motion carried unanimously.
