WHEREAS, offshore drilling activities pose threats to treasured vacation destinations along the entire New Jersey Coast including the Borough of Manasquan, which are an intrinsic economic value for numerous industries, provide important essential habitats for recreational and commercial fisheries, and

WHEREAS, the Borough of Manasquan recognizes that the tourism and fishing industries, which depend on a healthy and vibrant coastal environment, both serve as major economic drivers benefiting current and future residents, property owners, and visitors to the Jersey Shore; and

WHEREAS, the Borough of Manasquan endeavors to be a good steward of the state and region's environment and its resources; and

WHEREAS, exploration and development of oil and gas resources off the east coast of New Jersey will not effectively address the long-term energy needs of the United States; and

WHEREAS, offshore oil and gas drilling and exploration, including seismic air gun blasting in the Atlantic Ocean in close proximity to New Jersey's shoreline would put New Jersey's environment, beaches, marine resources, and local economies at risk;

NOW, THEREFORE, BE IT ROSOLVED BY the Mayor and Council of the Borough of Manasquan that:

- The Mayor and Council of the Borough of Manasquan oppose offshore oil and gas drilling, exploration, and development, including seismic air gun blasting, in the Atlantic Ocean off the East Coast of New Jersey.
- 2. The Mayor and Council of the Borough of Manasquan urge the United States government not to pursue or allow offshore oil and gas drilling, exploration, and development, including seismic air gun blasting, in the Atlantic Ocean off the East Coast of New Jersey.
