Brenda Darcy, Main Street business owner voiced her opinion on the requested event and that she is in favor of it.

Ms. Petula inquired about changing the time for the event to 3 to 9 pm or 3 to 8 pm.

Council Member Bossone stated that he could not support the event closing Main Street on a Saturday in July.
