#### **COMMITTEE REPORTS**

Public Safety & Recycling –Council Member McCarthy reported that he spoke to the Chief Pro Tem and was informed that the Division of Police Training has advised the new police officer hired at the end of last year, Ken Hamill, that he is exempt from attending the full academy. Mr. Hamil was required to attend a 1 day orientation on January 9 and over the next 5 ½ months he will be required to attend 17 classes and then he will be fully certified as a Police Officer on May 24, 2012 and during that period when Mr. Hamill is not in training he will be scheduled to work as a Police Officer. He stated that the committee will be meeting to address the hiring and naming of the new Police Chief. He stated that the Planning Board will be meeting in March to take a comprehensive look at all the Borough's land use ordinances and address some of the concerns such as flag lots and building two houses on single lots.

Public Property and Parks Committee – Council Member Mangan reported that Tourism welcomed Jamie Besieda as a new member and he is looking to a very productive year. He advised that the parks and public property committee will be meeting to discuss the bulkheads and a request that was carried over from last year which is an Eagle Scout who will be working on improvements to Manito Park. He advised that the committee will be working on the Borough's energy policy and discussing how the Borough can work with different groups in town that are already promoting better energy projects.

Public Works Committee – Council Member Ed Donovan reported that the new water treatment plant should be on line mid February with further testing. He advised that Christmas Trees will be picked up until February 24. He also advised that the new mason dump truck has been delivered and it is being used by the Department of Public Works and it would be used to help out in the event there is any snow. He advised that the Public Works budget will be discussed this Saturday. He reported that the Environmental Commission will be distributing recycling information to business and multi family dwellings and the information will contain instructions on reports that those entities are required to file with the Certified Recycling Coordinator.

Administration and Finance Committee – Council Member Connolly reported that the budget meetings will start this Saturday, January 21, 2012 and there are 2 more schedule, Saturday January 28 and Saturday, February 11. She advised that the Fire District is having their public meeting tomorrow night regarding their budget at 35 Colby Avenue at 7:15 p.m. She also advised that the public will be voting on the Fire District Budget on February 18.

Beach Committee – Council Member Bossone welcomed Jamie Besieda to the Tourism Commission. He reported that he met with the Beach Manager and the Administrator to go over building plans. He advised that the committee will be meeting this week to go over the budget.

Council Member Connolly made a motion to open meeting to the public, seconded by Council Member McCarthy. Motion carried unanimously.

There being none Council Member Mangan made a motion to close the public portion, seconded by Council Member McCarthy. Motion carried unanimously.

Council Member Donovan made a motion to adjourn the regular meeting at 8:30 p.m., seconded by Council Member Bossone. Motion carried unanimously.
