The Borough Attorney read the title of ordinance 2103-12 for second and final hearing.

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 11 (DOCKS AND BULKHEADS) OF THE MUNICIPAL CODE TO ESTABLISH THE TERM OF LEASES AND RENTAL FEES FOR THE DOCKING AND MOORING OF BOATS, AND TO ESTABLISH DRY STORAGE FEES FOR BOATS, RECREATIONAL VEHICLES AND NONCOMMERCIAL TRAILERS IN THE BOROUGH OF MANASQUAN, MONMOUTH COUNTY, NEW JERSEY.

Mayor Dempsey asked if there were any questions or comments regarding ordinance 2103-12

Council Member Grasso expressed that he would like the fees to be reviewed for the future.

Council Member Mangan advised Council that the committee has already been discussing this matter.

Council Member Donovan made a motion to open the hearing to the public, seconded by Council Member Bossone. Motion carried unanimously.

Ed Hyer, 56 Second Avenue asked the council to address the acronyms that are on the agenda so they could be understood better by the public. He wanted to know if there could be more than 5% put aside for the repair of the docks.

Council Member Donovan made a motion to close the public portion, seconded by Council Member Bossone. Motion carried unanimously.

Council Member Mangan made a motion to pass and publish according to law ordinance 2103-12, seconded by Council Member McCarthy. Motion carried by the following vote, "yes" Council Member Bossone, Connolly, Donovan, Grasso, Mangan, and McCarthy, "no" none.

APPROVAL OF MINUTES

Work Session Minutes – September 12th & 26th, 2011 Regular Session Minutes – September 12th & 26th, 2011

Council Member McCarthy made a motion to approve the minutes, seconded by Council Member Donovan. Motion carried with Council Member Bossone and Mangan abstaining.

COMMITTEE REPORTS

Public Safety & Recycling —Council Member McCarthy reported on the Police Department assisting the Prosecutor's office with an investigation where a County Prosecutor Officer discharged his firearm wounding a pit bull during the issuance of a warrant on Brielle Road. He advised that the committee and the administrator met with Chief Pro Tem Correia and that a decision will be made in the near future as to the hiring of a Police Chief.

Public Property and Parks Committee – Council Member Mangan reported that the Fish and Game Commission inspected Mac's Pond and issued a report that everything is ok and opening day for trout season is April 7, 2012. He advised that the geese wire will be removed on Thursday April 5, 2012. He thanked the Mayor for the new government reorganization committee and he looks forward to working with the other two members of council and the rest of council towards working and creating a more efficient government. He advised that the Life Saving Preservation Committee had its annual meeting on Saturday and many members of the council were in attendance and they nominated and elected new members of the Board and Trustees. He congratulated Lia Trench for being re-elected as President and he is looking forward to working with her and the other board members. He congratulated and welcomed Greg Olivera as the new member of the Tourism Commission. He stated that he met with an Eagle Scout candidate who is looking to re-do Manito Park and a plan was presented to the council members. He advised that there will be a meeting later in the week where the committee will discuss the plan for the park. He advised that Tourism and the 125th Anniversary Committee and OEM and all the State and Local agencies are working together to make this celebration one to remember.

Law and Code Committee - Council Member Grasso had nothing to report at this time.

Public Works Committee – Council Member Ed Donovan reported that last day for Christmas tree pickup at curbside is Friday, February 24th. He advised that new bypasses and valves have been installed at the E. Virginia lift station which was a safety issue. He reported that the Brielle Road Lift Station pumps have been re-built and there is an on going program where the enforcement signs will be replaced to meet DOT standards. He advised at the new water treatment plant that the old wells are being capped and the new plant is expected to be on line by the end of the month. He advised that the Borough is waiting on a letter from Environmental Protection on well #9 which is one of the two (2) new wells. He reported that the Environmental Commission members assisted the Certified Recycling Coordinator John Keynton in distributing a report that is the owners/operates responsibility to submit to the town for recycling tonnage.

Administration and Finance Committee – Council Member Connolly reported that the committee met and reviewed and approved bills totaling \$7.1 million dollars. She reported that \$4.5 million went to the Board of Education; \$1.5 million went to the County. She stated that the bills can be reviewed by the public and they are located on the front desk. She reported that the next budget meeting will be Saturday, February 11, 2012 at 9 a.m. here at Borough Hall and the council will be reviewing the Police and Court Budgets. She stated that the Borough has gone out to sell their Bond Anticipation Notes and the successful bidder was Provident Savings Bank, the principal amount of the notes was \$300,000, interest rate 1.15%, date of maturity February 5, 2013.

Beach Committee – Council Member Bossone reported that the office trailers are scheduled to arrive on or about March 5, 2012 to be used for the season as the previous building has been demolished. He reported that the initial sales for the beach badges will take place at Borough Hall in the Council Chambers the week of April 16, 2012. He also reported that the committee has looked into other options with regard to the Beach Plans due to concerns from residents. He advised that the plan that will be submitted for approval for the Beach Building will be the original plans that were approved by the council at a previous meeting. He went over some other improvements to the areas which are still being discussed.

AUDIENCE PARTICIPATION

Council Member Connolly made a motion to open meeting to the public, seconded by Council Member McCarthy. Motion carried unanimously.

Tom Corcoran, Boy Scout Troop #59, 15 Willow Way, asked Council Member Bossone what the new beach pavilion would improve on from the old one.

Council Member Bossone stated that most of the problems with the old building are structural.

Council Member Connolly made a motion to close the public portion, seconded by Council Member McCarthy. Motion carried unanimously.

Council Member Connolly made a motion to adjourn the regular meeting at 8:35 p.m., seconded by Council Member Mangan. Motion carried unanimously.
