APPROVAL OF MINUTES

Budget Meeting - February 18, 2012 and February 25, 2012

Council Member Donovan made a motion to approve the minutes, seconded by Council Member Mangan. Motion carried unanimously.

COMMITTEE REPORTS

Public Safety & Recycling –Council Member McCarthy congratulated Sergeant Restivo and Officer Wagner. He congratulated Jeannie Hill and Officer Nicholas Norcia and asked that a letter be put into their personnel file for remaining on the phone with the resident during the entire process as well as Officer Nicholas Norcia for his professionalism in responding to an event on the beachfront for a suspicious person. He reported that the Shade Tree Commission had a successful event on April 27, 2012 for Arbor Day and was well attended at the elementary school. He reported that JCP&L has started pruning trees throughout the entire Borough and he advised that there will be a bid going out for shade tree elevation shortly. He reported that there is a planning board meeting next Tuesday where the planning board will be reviewing various miscellaneous land use ordinances.

Public Property and Parks Committee – Council Member Mangan reported for Law and Code in the absence of the Law and Code chairman and read the Code Department report from Mr. Callahan, the Code Official. He reported on parks and public property that an ordinance was passed tonight for the Little League Shack demolition and the committee met and reviewed the draft agreement for the Life Saving Station and there were a few changes made and it will go back to the full council for review at the next scheduled meeting. He went over the Borough Hall improvement ordinance. He reported that the Boat Parade will be August 21, 2012 with a rain date of August 22, 2012 for the 125th Anniversary of Manasquan and it will be sponsored by the Tourism Commission and applications will be available starting on Memorial Day at Borough Hall as well as the Coast Star, Ocean Star, and the Corner Bagelry after Memorial Day.

MAY 7, 2012

Public Works Committee – Council Member Donovan reported that there was a paper shredding event on May 5, 2012 co-sponsored by the Brielle Department of Public Works and the Manasquan Department of Public Works. He reported that May 19, 2012 is the town wide yard sale. He reported that the Chamber of Commerce is having its Sidewalk Sale on Sunday and the Taste of Manasquan event and tickets are on sale for \$20 in advance up to Saturday and on Sunday they will be \$25. These tickets are on sale at Book Town, Bouquets to Remember, The Gatherings, Manasquan Lighting and the Corner Bagelry.

Administration and Finance – Council Member Connolly reported that a new telephone system has been installed at Borough Hall and one of the features is that it will have the ability to call borough residents in case of emergencies. She stated that more information will be available in the near future as to how this will work. She reported that there are over 1200 residents signed up for e-bulletin through the borough website. She reported that 14 companies and 29 drivers have applied to date for taxi applications and there were 60 food establishment licenses issued and notifications have been sent out and are due by June 1 at \$100 a permit. She reported that the committee has reviewed all the bills totaling \$2,151,787 and \$1.5 million of that amount is paid to Monmouth County for taxes. She advised that a letter has been received from the Republican Municipal Chair with the recommendations of the required three (3) names to fill the vacancy on the council to be considered at the next meeting.

Beach Committee – Council Member Bossone reported that there are no dogs allowed on the beach until November 1. He stated that all the parking passes have been sold out for the beach and the bathrooms will be open daily from 8 a.m. to 6 p.m. and as it gets later in the season they will be opened later. He went over the work that has been done at the beach and the beach looks wider this year. He went over the lifeguard qualification test this weekend and beach sales are tracking close to what they have been in the last few years. He went over the hours for the beach sales and he went over the status of the new beach building.

Council Member Donovan asked if Mr. DeIorio would comment on the Squan Plaza Plans.

Mr. DeIorio stated that the Public Works Committee has had several meetings reviewing different options, receiving input from the public, looking at past and current plans to make appropriate modifications that will suite as many of the needs of the Borough residents as possible. He stated that at this point the Public Works Committee is ready to present the revised plans to the public and to hold a public outreach forum to the members of the community. He advised that the date for this meeting will be Wednesday, May 23, 2012 at 6:30 p.m. He stated that the plans are currently under additional revisions so they are not available at this time. He advised that the input from residents was considered and that there was a meeting with Mr. Levinsky to give him an additional opportunity to meet and discuss his plans and how it could be coordinated with the revised plans. He advised that there has been a lot of time over the last several years in putting together a comprehensive plan for Squan Plaza which is hoped to address as many needs for all the interested parties. He stated that the goal is to break ground in October to avoid interrupting as few as possible events that are held at Squan Plaza.

AUDIENCE PARTICIPATION

Council Member Connolly made a motion to open meeting to the public, seconded by Council Member Mangan. Motion carried unanimously.

Jack Drew, resident wanted to know if the plan for Squan Plaza would be available to the public prior to the meeting of May 23, 2012.

Mr. DeIorio stated that it would depend on how quickly the plans can be revised and then the plans would be brought back to the committee for review. He stated that the meeting will be the unveiling of the plan to the public. He stated that he could not commit to an answer of the plans being available prior to the meeting.

Marilyn Jacobson, 59 McLean Avenue stated that she does not understand the process and would like some clarification with the bond being approved for the beach building and will the Borough be spending \$1.6 million.

Council Member Bossone stated that can not be answered until estimates come in.

MAY 7, 2012

Ms. Jacobson stated say the estimates come in at \$700,000 and what happens to the balance of the \$1.6 million.

Council Member Mangan stated that the balance would be cancelled.

Ron Jacobson, 59 McLean Avenue asked who Mr. Levinsky is.

Council Member Donovan stated that he is a landscape architect that did a plan for Squan Plaza about 6 years ago which was submitted through the Drews.

Mr. Jacobson stated that it is his understanding that the water plant is not on line yet and wanted to know why.

Council Member Donovan stated that the plant is running right now and has been for the last week but the project is not completed yet.

Council Member Connolly made a motion to close the public portion, seconded by Council Member Mangan. Motion carried unanimously.

Council Member Mangan made a motion to adjourn the regular meeting at 9:00 p.m., seconded by Council Member Bossone. Motion carried unanimously.
