COMMITTEE REPORTS

Public Safety & Recycling —Council Member McCarthy reported that the violations written by the Police Department are just about at a 5 year high. He reported that the committee discussed staffing issues within the police department. He reported that the intersection of Blakey and Curtis was discussed as to the appropriate traffic control.

Public Property & Parks – Council Member Mangan reported that he was working with the CFO regarding a funding plan to begin discussions with replacing the Borough bulkhead or at least repairing them. He

reported for Tourism that the Lighted Decorated Boat Parade celebrating Manasquan's 125th Anniversary on Tuesday, August 21, from 5 to 9 p.m. Manasquan Elks is sponsoring the event and the Beach House, formerly O'Neills, is sponsoring the fireworks. He stated that applications are still being accepted to participate. He reported that September 21 is a cocktail party, September 22 is a parade and September 23 is Clambake in celebration of the Manasquan's 125th Anniversary and shirts are still available.

Law and Code Committee – Council Member Jacobson reported that zoning collected \$550 for permits in July and code enforcement collected \$2,036 for permits, \$11,954 was collected by the building department. She reported that the courts took in \$117,113.10 and the town will receive \$92,799.04. She mentioned that the trash on Ocean Avenue has been looked into and there is a change in the scheduled date of pickup for that area. She asked about a dock master and the trash cans at the docks.

Public Works Committee - Council Member Donovan had nothing further to report at this time.

Administration and Finance – Council Member Connolly reported that residents should be aware that they have until August 10, to pay their property taxes without interest and the water bills have gone out and are due August 17. She reported that the bills have been signed by the committee and they are available for the public to view at the front desk.

Beach Committee – Council Member Bossone reported that revenues for the beach year to date are \$1,483,000 which is down about \$74,000 from last year. He went over the events that will be held at the beach in the next few days. He reported that the non-operational sinks at the Ocean Avenue bathrooms are due to a leak in the wall and are scheduled to be fixed shortly. He reported on the Clambake date, price, places to buy tickets, etc.

AUDIENCE PARTICIPATION

Council Member Connolly made a motion to open meeting to the public, seconded by Council Member McCarthy. Motion carried unanimously.

Dick Meincke, 36 N. McClellan wanted to know the progress on reviewing the police dispatchers.

Council Member McCarthy stated that is one of the items that have been discussed in committee meetings. He stated that some issues may involve contractual issues so he does not want to comment on it at this time but there is an ongoing review of the department.

There was discussion on the dispatchers and shared services.

Council Member Mangan made a motion to close the public portion, seconded by Council Member Donovan. Motion carried unanimously.

Council Member Donovan made a motion to adjourn the regular meeting at 9:29 p.m., seconded by Council Member Mangan. Motion carried unanimously.
