March 29, 2014, Special Meeting

Council Member Donovan made a motion to approve the minutes, seconded by Council Member Sinneck. Motion carried unanimously with Council Member Bossone abstaining.

COMMITTEE REPORTS

Public Safety & Recycling – Council Member McCarthy congratulated the Bossone family on 50 years of service to the Borough. He reported that as of April 1 dogs are not allowed on the beach and/or the walkway and summonses will be issued and signs have been posted. He also reported that Route 71 is being paved and for the next few days please anticipate in addition to the noise some traffic delays during the night time. He advised that the PBA fishing contest is May 3 at Mac's Pond and he thanked the Chief and Lt. Bauer for going through the interviewing and hiring process for the Records Clerk. He reported that all of the police officers completed the semi-annual firearms training and night time pistol qualifications within the last two weeks. He stated that in March Sergeant Restivo and Patrolman Smith attended and completed police rifle instructor training. He advised that he spoke with Council Member Olivera, Council Member Donovan and Superintendent Tom Nicastro regarding runs in town to establish some procedures that can be implemented going forward to limiting the runs in town.

Public Property and Parks Committee – Council Member Olivera congratulated the Bossone family on 50 years and hoped it to be 50 more. He reported that Parks Day last Saturday was a success and thanked Council Members Bossone and Mangan, Administrator DeIorio and John Keynton from Public Works for attending. He reported that the attendance was good and the response from the community was good. He advised that there were positive feedback and there were some concerns with geese, trees, and grass. He

reported that there are only 3 large boat slips available to rent and the finalization of the generator at borough hall is compete. He advised that the MS Walk scheduled to end at the North Main Street Parking Lot has been cancelled.

Council Member Bossone advised the council that the dead trees between the Beach Headquarters building and the condos are the Borough's and the beach is looking to replace them.

Administration and Finance Committee – Council Member Mangan thanked everyone that was involved in putting the budget together and that time was invested to make sure that every single line item is looked at, every potential source of revenues is sought out. He stated that this process is done in a group and is done non-politically and the best job was done for the taxpayers.

Public Works Committee — Council Member Donovan reported that public works recently completed the hydrant flushing in town which was done over night for the first time trying not to impact the residents too much and it seems to have worked out well. He advised that spring curbside brush and leaf pick up has been completed and leaves can now be dropped off at the borough yard in open containers during normal business hours. He reported that public works is working on improving the parking by the Little League Field by moving the curb stops back about 5 feet into the grass. He also reported that a part-time keyboarder has been hired for DPW. He reported that the Environmental Commission is holding a home composting workshop this Thursday, April 25 at 7 p.m. at the Recreation Annex on Atlantic Avenue, Saturday, April 26 there will be a beach sweep and Manasquan is having a paper shredding event on Saturday, May 24 at Fourth Avenue parking lot from 9 to 12. He also congratulated the Bossone Family.

Law and Code Committee – Council Member Sinneck thanked Council Member Mangan on his leadership on the Administration and Finance committee and working closely with Council Member McCarthy and he stated that it is non-political and that is a good thing. He thanked everyone else that was involved with the budget process. He congratulated the Bossone Family. He advised the process in the code/construction department is going swimmingly and the process improvements and system that have been implemented has brought the backlog down. He reported that the committee will need to address the remaining properties that are vacant and unaddressed which is about 39 homes.

Beach Committee - Council Member Bossone reported on the process for the Sea Watch parking and locker rental for this year. He advised that starting May 15 the parking lot at Sea Watch will be parking by permit only. He advised that the following projects have started or are waiting to be started are Third Avenue Parking Lot, repairs of the Beach Walk at the South end, Main Street and First Avenue road paving in front of Beach Headquarters, Pompano back lot to be surveyed and regraded by the County, camera system at the beach buildings, sand sifting at the beach garage, Sea Watch locker building siding, fencing in the back of Pompano lot by dumpsters, and a new project that should be started soon to replace the line of trees by the Beach Headquarters building and the condos next door. He stated that the sign on the Beach Headquarters was installed in the past week and they are waiting on electrical hook ups. He reported that pre-season beach badge sales are up about 30% compared to last year and this puts the beach revenue in line with 2012. He advised that there are 65 parking passes left for sale and the sales will resume Saturdays and Sundays from 10 to 2 from now until Memorial Day. He reported that the Brielle bathroom will be open starting on May 3 from 8 a.m. to 6 p.m. and the rest of the bathrooms will be open starting on May 17. He reported that no dogs are allowed on the beach or walkway until November 1. He reported that the Tourism kickoff/ribbon cutting ceremony will take place on May 22 starting at Main Beach and then a cocktail party at Leggetts to follow.

AUDIENCE PARTICIPATION

Council Member Donovan made a motion to open meeting to the public, seconded by Council Member McCarthy. Motion carried unanimously.

Mary Ryan, 113 Beachfront inquired about a letter that the beach front owners received from T&M Associates regarding an application to the DEP for grooming the beach. She stated that she had received a few e-mails and phones calls from beachfront residents who are concerned about the openings that are shown on the map. She stated that the other concern that residents have about the letter and the diagram is that it does not make any reference to the North End openings and wanted to know if those openings will be closed.

Mayor Dempsey stated that when the dunes are re-done the opening will be there to get onto Potters Beach, but all the ones that have been cut in over the years will be closed per DEP.

Ms. Ryan asked if the official one will be maintained.

Mayor Dempsey stated that he is not sure why the picture was sent to residents as there are not dunes and that this application is for grooming the sand.

Council Member Mangan stated that anything that goes out to the public needs to be copied to all members of council.

Mr. DeIorio stated that in the application it requires the engineer to submit letters to the residents for the CAFRA application.

There was discussion on what was sent out to the homeowners and the openings for the beach.

Ms. Ryan stated that the projects at the beach are going great however she noticed that there is already repaired the edge of the walk way and it looks like one of the big trucks has damaged the repair already.

Mayor Demspey asked where she is talking about.

Ms. Ryan stated that the damage is between the Inlet and Pompano. She also stated that trucks are coming onto the walk way without permits and she stopped a truck on Saturday where they were blocking the walk way and asked if they had a permit to be on the walk way and they stated that they did not and that they did not need one.

Council Member Bossone advised Ms. Ryan that she should call the police department to send someone out

Chief Correia stated that he appreciates Ms. Ryan's involvement but she should not get involved in these situations and she should call the police department.

Ms. Ryan commented on the signs for the dogs on the beach and was appreciative of them. She thanked everyone that was involved with the budget work and she appreciates the transparency about telling the residents of what is going on.

Council Member Sinneck made a motion to close the public portion, seconded by Council Member Mangan. Motion carried unanimously.

Council Member Donovan made a motion to close the regular meeting at 8:51 p.m. seconded by Council Member Mangan. Motion carried unanimously.
