A Special Regular Meeting of the Manasquan Mayor and Council was held on June 30, 2011 at 5:00 p.m., in the Council Chambers of Borough Hall.

Mayor Dempsey related that this meeting is being held in accordance with the Open Public Meetings Act of 1975 and that notice was given to the Coast Star and posted on the website June 29, 2011.

ROLL CALL: Present: Council Members Connolly, Donovan, Grasso, Lucas, and McCarthy

Absent: Council Member Lee

Also present was Mark Kitrick the Borough Attorney and Joseph Delorio the Borough Administrator.

## **USE OF BOROUGH PROPERTY:**

Block Party Request - Cedar Avenue - July 9, 2011

Mayor Dempsey if there were any questions regarding this request.

Council Member Connolly wanted to know about the liquor question. She stated that the Borough received a certificate of liability insurance and it is to insure Host Liquor Liability and she would like that to be explained.

Mayor Dempsey stated that the event can only be until 9 p.m. instead of 11 p.m., second it is marked on the front page no alcohol and further back it is marked that alcohol will be served. He stated that Mr. Long knows that he can not have alcohol on Borough property or Borough right of ways and the alcohol will be on private property and he is showing that he has liquor liability.

Council Member Connolly wanted a clarification as to the liquor liability being in another name besides Mr. Long.

Mayor Dempsey stated that does not make a difference.

Michael Long, 44 S. McClellan stated that the party is being hosted directly in front of Bob Giunco's house between Dewey and Farragut and he is the one providing the host liquor liability and his insurance agent advised that this is the way to handle it.

Mr. Delorio recommended that a motion be made with the conditions that the application be modified to end at 9 p.m. and that no alcohol shall be served or consumed on Borough property or Borough right of way.

Council Member McCarthy made a motion to accept the request with the recommendation of Mr. Delorio, seconded by Council Member Lucas. Roll call was taken and the motion carried unanimously.

There was discussion on the parking time frame for ordinance 2087-11.

It was recommended to have the time limit set at 20 minutes.

## **AUDIENCE PARTICIPATION**

Council Member Donovan made a motion to open the meeting to the public, seconded by Council Member Lucas. Motion carried unanimously.

Jim Brown, 19 Euclid Avenue thanked the Council for acting quickly on this matter. It stated that the 15 or 20 minute time limit is a reasonable time. He stated that he believes the taxi cabs parked on the street for days do represent a health issue and safety issue.

Janice Shibla, 90 Euclid Avenue stated that this ordinance is great and she is happy about that. She stated that there are cars hanging over driveways and she wanted to know if there could be set back lines painted by the driveways.

Mayor Dempsey asked Council Member Donovan to contact Mr. Nicastro Superintendent of Public Works and see if the lines can be painted by the driveways to define the parking area.

Council Member Donovan made a motion to close the public portion, seconded by Council Member McCarthy. Motion carried unanimously.

ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 (TRAFFIC) AND CREATING SECTION 7-7.11 ENTITLED RESTRICTION FOR OMNIBUS OR LIMOUSINE PARKING IN THE BOROUGH OF MANASQUAN, COUNTY OF MONMOUTH, STATE OF NEW JERSEY

Council Member McCarthy made a motion to introduce ordinance 2087-11 which states the time limit for parking at 20 minutes, seconded by Council Member Donovan. Motion carried by the following vote, "yes" Council Member Connolly, Donovan, Grasso, Lucas and McCarthy, "no" none.

Mayor Dempsey advised that the second reading of ordinance 2087-11 will be on July 18, 2011.

Council Member Connolly made a motion to adjourn the regular meeting at 5:40 p.m., seconded by Council Member Lucas. Motion carried unanimously.
