He went over the time frame that leashed dogs are allowed on the beach only and never allowed on the walkway at any time. He went over the research as to who can write tickets for dogs on the beach.

Mr. Delorio recommended that the council consider banning dogs completely from the beach front area and that would alleviate having the problem of when they are allowed and not allowed.

Council Member McCarthy stated that this is a law that needs to be enforced and some people will not be happy with the results of the tickets but it needs to start happening now.
