JANUARY 25, 2014

Mr. DeIorio updated the council on FEMA worksheets that have been submitted and what still is ongoing. He stated that the Borough has received notification that the \$4.5 million project worksheet has been obligated and it has been sent to the State and we are supplying additional information to the State. He advised that the State has given the option of doing the audit while the information is being submitted and not waiting until the end of the process. He stated that Donna is adding more documents to that for the audit that is in process. He stated that the Borough has a Special Emergency Note that will be rolling over in March and he went over the time table and the amount that will be needed for this note. He reported that the State has assured the Borough that once it is released from their review the finance should be within a week.
