FEBRUARY 18, 2014

A Work Session Meeting of Mayor and Council was convened at 7:00 p.m. on February 18, 2014 in Council Chambers of Borough Hall with Mayor Dempsey presiding.

Mayor Dempsey's statement re: Open Public Meetings Act of 1975 and that notice was given to the Coast Star and the Asbury Park Press on December 30, 2013.

PRESENTATION: Recreation Commission

Council Member Donovan introduced Eric Ertle, Chair of the Recreation Commission.

Eric Ertle, Recreation Chairman presented council with a request to employ a part-time recreation coordinator for 20 hours a week which would be paid out of the Recreation Commission Trust Account. He stated that they would like to stream line on line sign ups and have one person in charge to oversee the programs. He also presented a request for the Borough Attorney to negotiate a lease for Manasquan Recreation Commission to lease out extra space for recreation events which would also be paid out of the trust account which is money that Recreation received through fundraisers and that no taxpayer dollars will be used.

Council Member Donovan stated that it is his understanding that the lease would be for one year with a condition for a first right of refusal if the building went up for sale during that period of time and it could be renewable for a longer period of time if everything worked out.

Council Member Donovan made a motion to authorize the borough attorney to negotiate and enter into an agreement for a lease for additional space for recreation on Atlantic Avenue, seconded by Council Member Sinneck. Motion carried unanimously.

Council Member Donovan made a motion to authorize the clerk to advertise for a parttime recreation coordinator, seconded by Council Member Bossone. Motion carried unanimously.

Both of these motions will be memorialized at the next meeting.
